PLEASE NOTE: It is illegal to work in the Alarm and Locksmith Industry under any of these licensed categories if not employed by a licensed company.

As of July 11, 2013, in accordance with OAC 310:75--2(b)(1), all individual licenses will expire on the last day of the licensee's birth month. The license holder is responsible for the renewal of this license on or within ninety (90) days prior to the expiration date specified on the card.


